Admission Notification for Master of Computer Applications (MCA) 2016-17

In exercise of the powers conferred by section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra has notified on 11th March 2016 the rules to regulate admissions to the First and Direct Second Year of Full Time Professional Post Graduate Technical Courses (Engineering and Technology, Pharmacy, Architecture, Hotel Management and Catering Technology, Management and Computer Applications). These rules are called the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Post Graduate Technical Courses) Rules, 2016. These rules are also applicable for admissions in Government and Government Aided institutions vide Government Resolution of Higher & Technical Education Department No. TEM-2016/CR 536/TE-4 Dated 15th March 2016.

This notification is being issued for Online Registration, Documents Verification and Application Form Confirmation at Facilitation Centres (FC) by candidates willing to be admitted in First Year / Direct Second Year (Separate Division & Lateral Entry) in Master of Computer Applications (MCA) in the Government, University Managed, University Departments and Unaided Institutes for the Academic Year 2016-17 in the Maharashtra State.

Aspiring candidates are informed to read the PG rules for admission & eligibility requirements from the website <http://www.dtemaharashtra.gov.in/mca2016>.

Eligibility for admission for First Year

Candidate should be an Indian National and should have passed minimum three year duration Bachelors Degree awarded by University recognized by University Grants Commission or Association of Indian Universities in any discipline with at least 50% marks in aggregate or equivalent (at least 45% in case of candidates of backward class categories and Persons with Disability belonging to Maharashtra State only) **and** should have studied Mathematics as one of the subjects at (10+2) level or at Graduate level examination **and** Obtained score in MAH-MCA-CET 2016.

Candidate should have passed minimum three year duration Bachelor's Degree awarded by University recognized by University Grants Commission or Association of Indian Universities in any discipline with at least 50% marks in aggregate or equivalent **and** should have studied Mathematics as one of the subjects at (10+2) level or at Graduate level examination;

Eligibility for admission for Direct Second Year

Candidate should be an Indian National and should have passed minimum three year duration Bachelor Degree in Computer Applications or Science (Information Technology or Computer Science) with at least 50% marks in aggregate or equivalent (at least 45% in case of candidates of backward class categories and Persons with Disability belonging to Maharashtra State only) **and** should have Studied Mathematics as one of the subjects at (10+2) level or at Graduate level examination **and** Obtained score in MAH-MCA-CET 2016.

Candidate should have passed minimum three year duration Bachelor Degree in Computer Applications or Science (Information Technology or Computer Science) with at least 50% marks in aggregate or equivalent **and** should have Studied Mathematics as one of the subjects at (10+2) level or at Graduate level examination.

Important Note:-

1. All types of candidates including minorities aspiring for admission under CAP seats, it is **mandatory** to get registered and get Documents Verified and Confirmed at Facilitation Center.
2. As per the Rule No 3 & 13 of the notified rules, candidates aspiring for admission for Institutional Quota, vacant seats after CAP, Supernumerary Seats for Children of NRI/OCI/PIO, Children of Indian workers in Gulf Countries, Foreign National Candidates, it is a **prerequisite & mandatory** to get documents verified and confirmed at facilitation centers.
3. Only those Candidates who have verified and confirmed documents at Facilitation Centers and having CAP Merit number shall be eligible for admission for all types of seats/quota.

Important Instructions for candidate:

1. The candidates are required to show the **documents in originals** at this stage of verification and Conformation of Application Form at FC. Candidates are advised to keep the necessary documents ready at the time of Document verification stage as per the notified schedule.
2. If candidates fail to confirm online filled application form at FC, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission.
3. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC and SBC categories should produce "Caste Validity Certificate" issued by Scrutiny Committee of Social Welfare Department and the Candidate belonging to ST category should submit "Tribe Validity Certificate" issued by Scrutiny Committee of Tribal Department. All Backward Class candidates excluding SC & ST should produce Non Creamy Layer certificate **valid up to 31st March 2017 at the time of verification of documents** at FC, if these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats in the admission process.
4. Application received after the due date from candidates belonging to J & K Migrant categories will be summarily rejected and no correspondence will be entertained in this regard. Such Candidates will get the **Receipt-cum-Acknowledgement** through their login after confirmation of application form.
5. Reserved category candidates not producing Caste Validity Certificate are required to submit Xerox copy of Pro-forma H on Rs.100/- Non Judicial Bond Paper (available on website for download) and original shall be retained by the Candidates which he/she shall submit to the Institute during admission.
6. Candidates who have registered as a reserved category candidate but could not produce required documents for reservation claim during document verification phase shall have to pay difference amount of fees of ₹ 200/- at the FC in cash.
7. **Candidates are advised to ensure before applying for the admission to the MCA programmes in a particular University that he/she is eligible for admission to the programme as per the relevant Eligibility Rules of that University.**
8. **It should be noted that there shall be no admission for Direct Second Year (Separate Division & Lateral Entry) in the MCA Institutes under the jurisdiction of universities which do not have such provisions under their eligibility criteria. Names of such universities will be displayed separately on the website.**

General Notes:

1. Candidate can avail the facility free of cost which is available at Facilitation Centre (FC) for submission, confirmation of Application form.
2. All FC's shall remain open on all days including holidays and Sundays for submission & confirmation of application form during the schedule. For FC List and address refer website.
