
**TERM & TERMINATION:**

- MOU Being Of Academic Nature Does Not Belong Any Commercial Liability Unless Any Services Are Delivered.

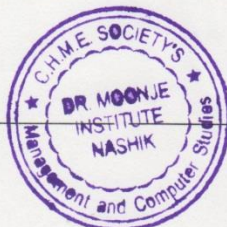


